The theme of our Annual Report this year is "Clean Water — For the People, By the People." In this report, we are highlighting the many layers of people and organizations that are involved in ensuring our customers continually receive the finest quality water that is always highly reliable and economical. It starts at the top with the federal Environmental Protection Agency (EPA) and the Pennsylvania Department of Environmental Protection (DEP). They are

the regulatory agencies that set the most stringent water quality standards for all water utilities to adhere to. They hold us accountable and require that our water treatment processes and delivery systems measure up to the strictest quality and performance specifications, ensuring excellence in water quality and operations of our infrastructure.

Then the next layer of people involved are the member municipalities that we serve. In turn, those Township and Borough officials from our owner municipalities appoint their representatives to the Authority's Board of Directors. Those Board members represent the interests of their local communities, as well as the larger interests of the Authority's entire service area and customer base. Then it's NPWA's management team and employees who are tasked with carrying out the policies set by the Board, and managing the day-to-day operations of the water system. Then, of course, the last element in the chain of people involved are the customers themselves, who are the object of our entire organization's efforts. We have a total of just under 35,000 customers, at last count, which include residences, businesses, and industries in the North Penn region. Those customers receive the highest quality of water available, along with dependable service, at a very modest cost. Our average residential customer pays less than \$1 per day for all of their entire household's water needs. It's a great value, and a bargain that cannot be beat.

WATER NEWS Rain Garden in Lansdale

In honor of Drinking Water Week, which ran May 5 through May 11 this year, North Penn Water Authority (NPWA) and the Perkiomen Watershed Conservancy (PWC) partnered on a project to protect the Perkiomen Creek Watershed and beautify the community. A Rain Garden will be planted in Lansdale Borough this fall in large thanks to the community who voted on the Lansdale location through a Facebook poll hosted on NPWA's Facebook page.

A rain garden is a garden of native shrubs, perennials, and flowers planted in a small depression, where water tends to pool. It is designed to temporarily hold and collect rainwater runoff. It also filters pollutants out of rainwater runoff, much of which ends up in our waterways. As part of its commitment to environmental stewardship and watershed education, NPWA is committed to educating the public on the importance of watershed protection, source water protection and water conservation. Partnering with the Perkiomen Watershed Conservancy for the Rain Garden project helps NPWA take that commitment to the next level by implementing a project that will act as a filter to rain water and storm water runoff.

"We are happy to be working with Perkiomen Watershed Conservancy on the Rain Garden Project," said Anthony J. Bellitto Jr. P.E., Executive Director of NPWA. "We are in the business of providing our customers with clean, safe drinking water 24 hours a day and clean water begins at the source. By protecting source water, we are protecting drinking water."

"North Penn Water Authority is taking the next step to ensure its residents have access to safe, clean and reliable drinking water. We are thrilled to be a part of that step," said Ryan Beltz, Executive Director of the Perkiomen Watershed Conservancy.



Lansdale Borough has identified Whites Road Park as an ideal location for a Rain Garden. By planting a Rain Garden in this location, it will collect rainwater that normally overflows into the Towamencin Creek, preventing pollution and erosion into the creek. A rain garden will offer many benefits to those who utilize the park, such as an increase in birds, butterflies and wildlife as well as help foster healthier waterways.
