In this report, we are highlighting how we at North Penn Water Authority responded to the challenge of the coronavirus pandemic. I am happy to report that we kept the water flowing without interruption. As an essential life-sustaining business, we could not shut down our operations. Rather, our state-of-the-art water treatment plant at Forest Park and our water distribution system

infrastructure continued to function 24/7. Our dedicated staff remained committed to providing excellent quality water and reliable service around the clock to all of our over 35,000 customers who rely on this most vital commodity that our homes and businesses cannot live without.

We quickly adapted certain aspects of our operations in order to protect the health of our employees and customers, while continuing to provide the community with a safe, reliable, and economical water supply. Through our quick implementation of technology, along with efforts from management to stay up to date on changing health orders, increased reliance on remote communications, and great cooperation from our staff, NPWA was able to continue our operations without interruption, and stay on target with construction of our infrastructure improvement projects.

We also saw an increased demand for water among our residential customer base last year, since so many more people were working from home and attending school remotely, and everyone was being told to wash their hands more frequently. We had no problems with our water supply being able to meet those demands for increased usage.

WATER NEWS NPWA's Response to a Year Like No Other



North Penn Water Authority's (NPWA) 55th year in operation started like any other year. Staff came to work after the holidays and time spent with family and friends, ready to begin a new year with new goals and projects. However, as the world quickly learned, 2020 was not going to be the year anyone expected. For much of 2020, the entire world grappled with the devastating health and economic effects of the COVID-19 pandemic. Life as we knew it changed in a matter of weeks. The North Penn Water Authority's operations were no exception. As an essential business, NPWA along with the Forest Park Water Treatment Plant (FPW) had to adapt certain aspects of its operations in order to protect the health of employees and customers, while continuing to fulfill its mission of providing the community with a safe, reliable, and economical water supply. Through the quick implementation of technology, efforts from management to stay up-to-date on changing health orders, and cooperation from employees,

NPWA was able to fulfill its mission while staying on schedule and on budget with some major infrastructure improvement projects.

During a year of insecurity and uncertainty, NPWA is proud to say that customers could rest assured that NPWA drinking water was, and still is, safe to drink. According to the U.S. Centers for Disease Control and Prevention (CDC): "Conventional water treatment methods that use filtration and disinfection, such as those in most municipal drinking water systems, should remove or inactivate the virus that causes COVID-19." The World Health Organization adds that the "presence of the COVID-19 virus has not been detected in drinking-water supplies and based on current evidence the risk to water supplies is low."

WATER NEWS NPWA Releases Children's Activity Book


NPWA is excited to announce the release of its first children's book, "The Source to Tap Mystery," which was released on May 15, 2021.
