## **Construction Notice**

### **Project: East Main Street, Lansdale 8" Water Main Replacement**

North Penn Water Authority (NPWA) will begin the construction of a new 8" water main on East Main Street between Oakland Avenue and North Wales Road beginning on or about the week of April 7, 2025. We will be saw cutting the road for two days. Pipe installation will begin on April 14.

### **Project Summary:**

This new water main will replace older 8" cast iron water main prone to breakage and will enhance the public water supply and fire protection to the residents of the borough.

After completion of the water main installation, the water services will be renewed from the new water main to the property owner's curb stop located in the utility right of way behind the curb in the grass or sidewalk, followed by soil, concrete and trench restoration in the street, weather permitting.

We anticipate the construction work for the water main installation, service renewals and trench restoration to take approximately eight to nine weeks to complete, weather permitting. This work is being done in cooperation with Lansdale Borough and PADOT's scheduled mill and overlay.

### **Timeline:**

**April 7-8** - Saw cutting of the roadway

**April 14** - Mobilization and construction will begin

### **Customer Impact:**

In order to ensure the public and workers' safety, traffic control will be in place during the hours of work (9:00 am – 3:00 pm).

Both road lanes will be opened at the end of each work day and traversable.

School buses, emergency vehicles, and residents will have access to their homes, but may experience minor delays in some instances.

We will make every effort to keep unobstructed access open to local residents to the fullest extent possible.

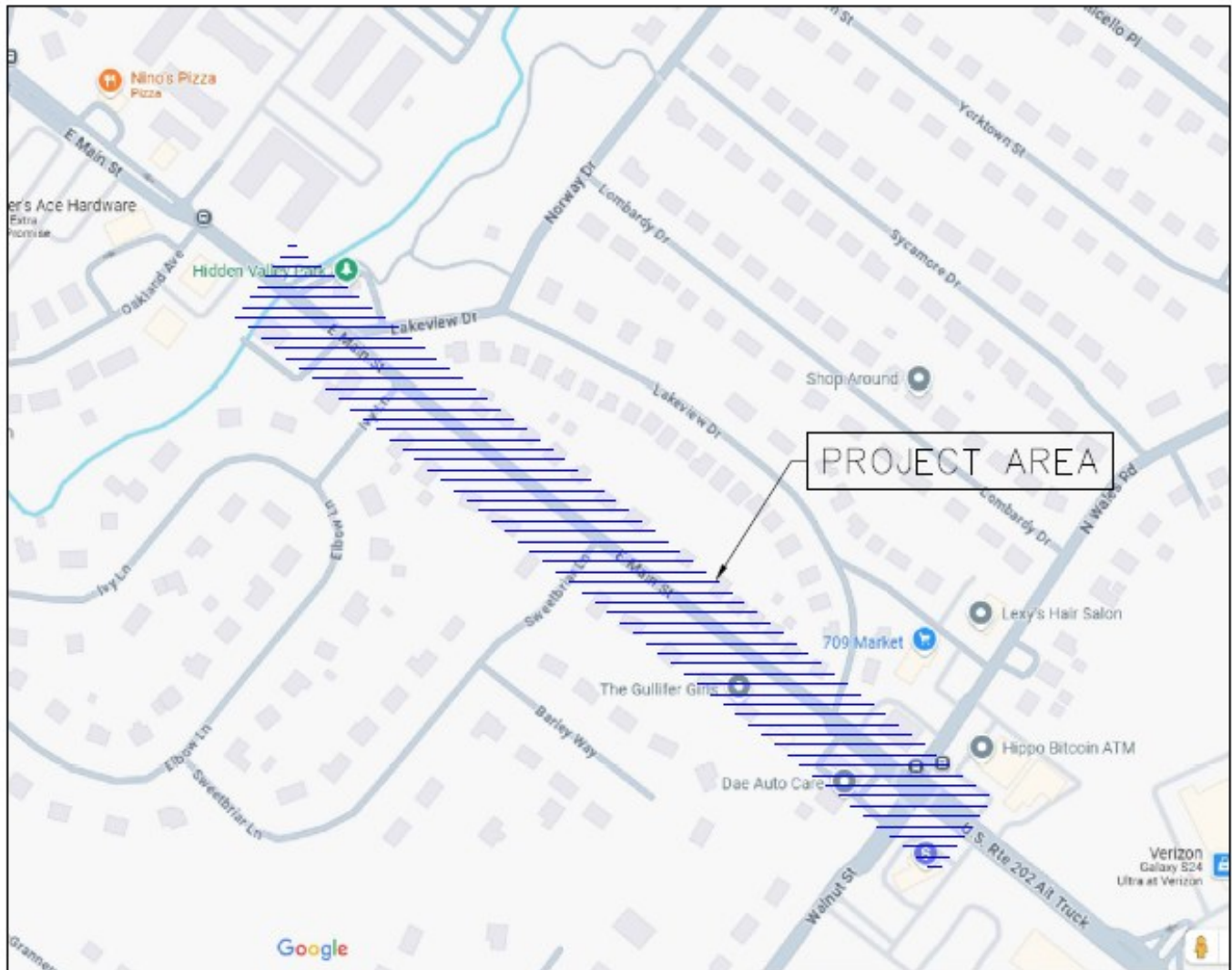
We have notified the School District and your local emergency response units to assure they will have access and that your essential services are not interrupted.

For your protection, we have documented the property frontage of your curbs, sidewalks, blacktop, lawns and driveways to ensure that any damage that may be caused is restored to a condition that is at least equal to the current condition. All concrete, blacktop, or grassy areas that are dug up will be restored.

We regret any inconvenience that you may experience during this period. This improvement project is part of our ongoing, asset management plan to replace older water mains in order to continue to provide our customers with high quality drinking water and adequate fire protection.
