## **Construction Notice**

### **Project: Railroad Avenue, Souderton**

North Penn Water Authority (NPWA) will begin the replacement of approximately 2,465 lineal feet of water main on Railroad Avenue and Harrison Avenue, in between N. Main Street and Central Avenue. This work is set to begin on September 7, 2026.

### **Project Summary:**

This project involves the renewal of 50 water services with copper water tubing. The water services will be renewed from the new main to the property's curb stop located in the utility right of way behind the curb in the grass or sidewalk followed by soil, concrete and trench restoration. There will also be four hydrants renewed on Railroad Avenue and Harrison Avenue. After all of the new water main, services, and hydrants are installed, trench restoration will commence.

We anticipate the work to take approximately seven weeks to complete, weather-permitting.

### **Timeline:**

**September 7, 2026** - Mobilization and construction will begin.

### **Customer Impact:**

In order to ensure the public and workers' safety, the roads will be closed to through traffic during the hours of work (7:00 am – 4:00 pm).

"No Parking" signs will be placed out the day before to designate the area of construction for that day. We kindly ask that you have your vehicle moved when your section of street is posted during construction hours.

At the end of each workday, the roadway will be open and traversable.

School buses, emergency vehicles and residents will have access to their homes, but may experience minor delays in some instances.

We will make every effort to keep unobstructed access open to local residents to the fullest extent possible.

When it comes time for water service renewals, please make sure to run the cold water only when prompted by the inspector, to ensure any air or discoloration are cleared from your water service. Having a working and available hose bib will help with this process.

We have notified your local emergency response units to assure they will have access and that your essential services are not interrupted.

For your protection, we have documented the property frontage of your curbs, sidewalks, blacktop, lawns and driveways to ensure that any damage that may be caused is restored to a condition that is at least equal to the current condition. All concrete, blacktop, or grassy areas that are dug up will be restored.

We regret any inconvenience that you may experience during this period.
